The Disposal Rules...

Domestic Waste

Domestic household waste must go in the bins provided. Waste unsuitable for compaction such as fridges, scrap iron etc. will be required to be placed in the designated areas.

Green Waste

Green Waste can be taken to the Waste Transfer Station for disposal.

Green waste will not be accepted if contaminated with rubbish. Green waste is not to be placed in the bins. Please place in the designated area.

Household Hazardous Waste

Household Hazardous Waste are flammable. toxic, reactive or corrosive products used in and around the home.

If not disposed of correctly, they can cause harm to humans, animals or the environment.

The Waste Transfer Station will **not** accept items such as batteries, paint, solvents, pesticides, flammable liquids, acids, alkali substances, light globes and fluorescent tubes.

Recycling

Recycling facilities are available at the Harrismith, Tincurrin and Yealering Recycle Stations. Please sort all recyclables at home and drop them at the station which is separate to the Waste Transfer Station.

The following clean, sorted recyclables are accepted:

- Clear and coloured glass
- Aluminium, tin and cans
- **Bundled** newspapers
- E-waste
- Scrap metal
- Used oil
- Car batteries
- Gas bottles
- Mobile phones
- Green waste for chipping

Waste not accepted...

- Hazardous Material
- Liquid Waste
- Contaminated Soils
- Flammable Liquids Radioactive Substances
- Unwrapped Asbestos
- Explosive Devices

The Rules...

- All domestic rubbish must go in the designated bins.
- The placement of all waste must be carried out as per the instructed signage.
- Lighting of fires is strictly prohibited.
- Scavenging is not permitted.
- Dumping of machinery/vehicles by appointment only.



The Locations... Tincurrin - Keeping Street Harrismith - Wickepin-Harrismith Road Yealering - Coxon Street

The current rubbish tips at Harrismith, Tincurrin and Yealering will be closed and be replaced with the Waste Transfer Stations.

It is anticipated that this will occur in August 2015.

All waste will be transported by contractor to the Wickepin rubbish tip for disposal.

Reasons for the closure...

- The present site is environmentally sensitive
- The present site will not conform to future Department of Environmental Protection requirements:
- There is a need to construct a suitable facility to meet the need for responsible recycling and future waste volumes anticipated.
